### **Voluntary Release, Assumption of Risk and Indemnity Agreement**

In consideration for being permitted to participate in voluntary Coaching, herein referred to as

“Strong Living Stones Inc.”, the undersigned, \_\_\_\_\_, **(print full name)** herein referred to as the “Releaser” agrees as follows:

#### **1. RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE.**

Releaser and Releaser’s personal representatives, assigns, insurer, heirs, executors, administrators, spouse and next of kin, hereby releases, waives, discharges covenants not to sue and release Leslie David Lane and Kerry Roma Lane, Strong Living Stones Inc., and its directors, officers, employees, agents, volunteers, LightMelbourne operating as 89.9 LightFM as well as its successors, assigns, affiliates, subordinates, and subsidiaries, all herein referred to as the “Releasees,” from any and all liability to Releaser, and to Releaser’s personal representatives, assigns, insurer, heirs, executors, administrators, spouses and next of kin for any and all loss, damage, or cost on account of injury to the person or property or resulting in the death of the Releaser, whether caused by the negligence of Releasees or otherwise while Releaser is participating in the Strong Living Stones Inc. and any other activities in connection with Strong Living Stones Inc.

Releaser assumes full responsibility for and risk of bodily injury, death or property damage due to negligence of Releasees otherwise while participating in Strong Living Stones Inc.

**IT IS FURTHER UNDERSTOOD AND AGREED** that this wavier and release constitutes an admission and acknowledgement by this undersigned that they have received no warranty, guarantee, or promise of any particular result either expressed or implied, from Leslie David Lane and Kerryn Roma Lane. The undersigned parties acknowledge and agree that the very nature of their problems(s) is necessarily such that no specific result(s) can be promised or warranted by any such Coaching service.
